- Eligibility:**                      Competitors must meet the following Criteria:
1. A member in good standing with USA Judo, USJA, USJF, or ATJA for USA competitors. A member of their national federation for international players. A copy of your current membership card will be required at registration.
  2. At least 30 years of age. Year of birth must be 1993 or earlier. Proof of age consisting of birth certificate, passport, or current USA Judo membership card having the age verification symbol "V" printed following the date of birth. **Note: A Driver's License is not acceptable as proof of age.**

**The Tournament Directors reserve the right to make any changes that are in the best interest of the contestants to achieve fairness and competition.**

**Match Times:** All Divisions (All Ranks):  
Under 60 years old 3 minutes match time and unlimited golden score  
60 years old and older 2.5 minutes match time and 1 minute golden score

**Judo Gi's:** Contestants are encouraged to bring 2 gis (1 blue & 1 White). First called contestant must wear white gi. Second called is encouraged to wear a blue gi, but a white gi with blue belt will be allowed. One contestant **MUST** have a white Judo Gi - No matches where both contestants have a blue Judo Gi.  
**BLUE AND WHITE BELTS WILL NOT BE PROVIDED**

**Rules:** **IJF Rules with the following modification**  
No Shime Waza in M7 and older Standard Division  
No Shime Waza and No Kensetsu Waza in Novice Divisions  
3 Minute match time and no limit to Golden Score: 30-59  
2.5 Minute match time and 1 minute Golden Score: 60 and up.

**Competition Method:** True double elimination system will be used for divisions of 6 or more. Round robin will be used for divisions of 5 or less. Divisions of 2 will be best of 3.

**Awards:** Medals will be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> in each division.
