Females: 30-34,35-39,40-44,45-49,50-54,55-59,60-64,65-69,70-74,75-79,80+
48kg,52kg,57kg,63kg,70kg,78kg, +78kg

Match Times: All Divisions (All Ranks):
Under 60 years old 3 minutes match time and unlimited golden score
60 years old and older 2.5 minutes match time and 1 minute golden score

Judo Gi's: **Novice Divisions:** Contestants are encouraged to bring 2 gis (1 blue & 1 white). First called contestant must wear white gi. Second called is encouraged to wear a blue gi, but a white gi with blue belt will be allowed. One contestant **MUST** have a white Judo Gi No matches where both contestants have a blue Judo Gi.

BLUE AND WHITE BELTS WILL NOT BE PROVIDED

Standard Divisions: Blue and White Gis are mandatory. They do not have to be IJF Approved but the fit must meet IJF standards.

Rules: **IJF Rules with the following modification**
No Shime Waza in M7 and older Standard Division
No Kensetsu Waza in Novice Divisions

Competition Method: True double elimination system will be used for all divisions. Divisions of 2 will be best of 3.

Awards: Medals will be awarded for 1st, 2nd, and 3rd in each division.

Eligibility: Competitors must meet the following criteria:
Member in good standing with USA Judo,
Member of their national federation for international players.
Copy of your current membership card will be required at registration.
At least 30 years of age. Year of birth must be 1993 or earlier.
(Acceptable proof of age: birth certificate, passport, or current USA Judo membership card having the age verification symbol "V" printed following the date of birth.)

Note: A Driver's License is not acceptable as proof of age.

The Tournament Directors reserve the right to make any changes that are in the best interest of the contestants and to achieve fairness in competition.

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that prior to participating, I will inspect the mats, equipment facilities, competition pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
